

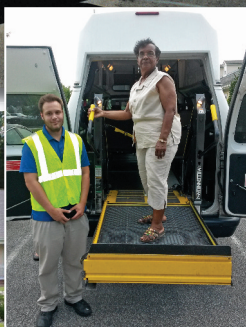

## Who Can Ride?

---



Any Pender County resident, 18 or older is eligible for our services. Parents must provide safety seats as the law requires.

## Cancelling a Trip

---



Failure to cancel a scheduled trip is called a "No Show". Notify PAS-TRAN at (910) 259-9119 to cancel any scheduled trip at least two hours in advance.

## SERVICE POLICY

- Children must be accompanied by an adult.
- Seat belts **MUST** be worn at all times.
- Guns and weapons are prohibited.
- Food, drinks, loud or disruptive behavior and the use of alcohol and tobacco products are prohibited.
- Passengers may not interfere with the safety or privacy of other passengers. Lift equipped vehicles are available.

*Transportation services may be interrupted if funding is not available.*
