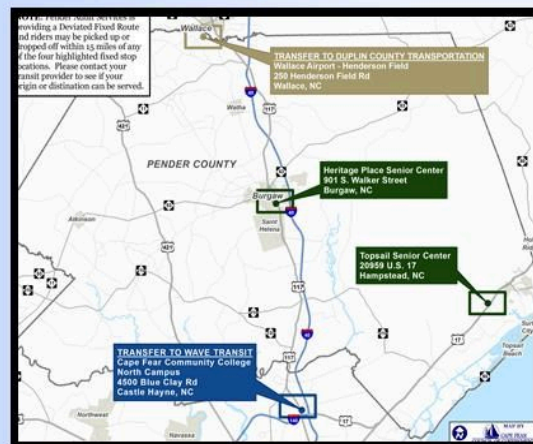

## Who can ride PAS-TRAN?

Seniors age 65 and up, any person with a disability (ADA), general public aged 18 or older, including area visitors. Valid ID required. Minors must be accompanied by an adult.

## How to Schedule a Trip

Reservations must be made at least 48 hours prior to your trip. Call or see website for current transit system information, fares and hours of operation, and to see if same-day service is available.

## Canceling a Trip

Failure to cancel a scheduled trip is called a "No Show". Notify transit system to cancel any scheduled trip at least two (2) hours in advance.

## PAS-TRAN Service Policy

- Guns and weapons are prohibited.
- Food, drinks, loud or disruptive behavior, the use of illegal substances, alcohol and tobacco products are prohibited.
- Passengers may not interfere with the safety or privacy of other passengers.
- Lift equipped vehicles are available.
- Credit cards are NOT accepted at this time.
- Certain restrictions may apply.
- Seat belts **MUST** be worn at all times.
- Parents must provide safety seats as the law requires.
